Subject: - Letter of intent prior to grant of recognition/permission under Clause 7(13) NCTE (Recognition Norms and Procedure) Regulations, 2014.

The Western Regional Committee in its 341st meeting of WRC held on 17th - 18th August, 2021 on the basis of scrutiny of the documents submitted by the institution, input received from the Visiting Team Report and video-graph CD, observed that the following institution has adequate financial resources, accommodation, library and laboratory as prescribed in the norms and standards and that it fulfils all such other conditions relating to infrastructural and instructional facilities as required for proper functioning of the institution for the proposed teacher education course, and decided to issue Letter of Intent under clause 7(13) of the NCTE Regulations, 2014 as amended from time to time:-

2. As per provision of clause 7(13) of the NCTE Regulations, 2014, as amended from time to time, the process of appointment of qualified staff as per policy of the State Government or University Grants Commission or University, may be initiated by the institution, and the affiliating body will provide all assistance to the institution to ensure that the staff or faculty is appointed as per norms for the course. The institution shall submit the list of faculty, duly approved by the affiliating body, to the Western Regional Committee within two months from the date of Letter of Intent.
3. In view of the above, before grant of formal recognition under clause 7(16) of the NCTE Regulations, 2014 is considered by the WRC, the following documents are required to be submitted by the institution: -
 - a. The institution shall submit particulars of the staff duly approved by the University/affiliating body in the prescribed format available on the WRC, NCTE website.
 - b. Copy of advertisement given for recruitment of faculty and staff.
 - c. An affidavit on Rs. 100/-stamp paper from the Management to the effect that the institution has selected staff as per NCTE/State/University norms.
 - d. Certificates of Educational & professional qualifications prescribed by NCTE in respect of all teaching staff showing their eligibility for appointment as per norms and experience certificate of the Principal /HOD. The institution is required to
